Future Roadmap

The list of features we want to add to Tabellion is quite large and getting larger all the time as more users contribute their ideas about how the application should grow. Here is a short list of features on our to-do list:

- A full-blown web-based client using the power of Microsoft Blazor and Web Assembly.
- A full resynch of meta data with ACAP, to include new judges, offenses and other types of data.
- Handwritten case notes
- Dependency Neglect cases
- Case archival, retrieval, export and import.
- Customizable client intake form that your client can fill out on their phone during the initial interview.
- PDF import and storage
- Case document templates, such as customizable invoices, letters, motions, etc.
- Emailing and printing of case documents

These are just a few of our planned features, but we would love to talk to you about capabilities that you think would make good additions and work with you to make them a reality.

Here are some thoughts about Tabellion from attorneys who have used it to improve the efficiency of their practice:

Tabellion saves time by allowing real-time billing and uploading of claims. Instead of spending 15-45 minutes billing each case and keeping track of countless pages of time sheets, I can upload the case data, documentation, and time information into ACAP while I work each case, and then spend less than five minutes per case double-checking data before submitting it. Once you start using Tabellion, you won't ever want to practice without it.
