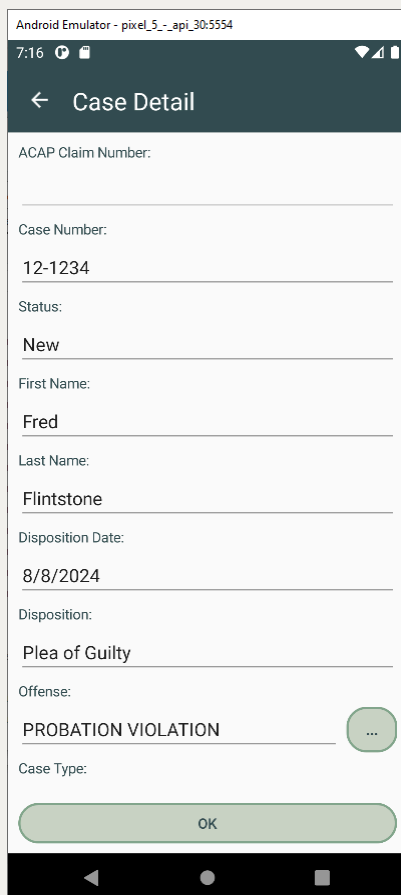
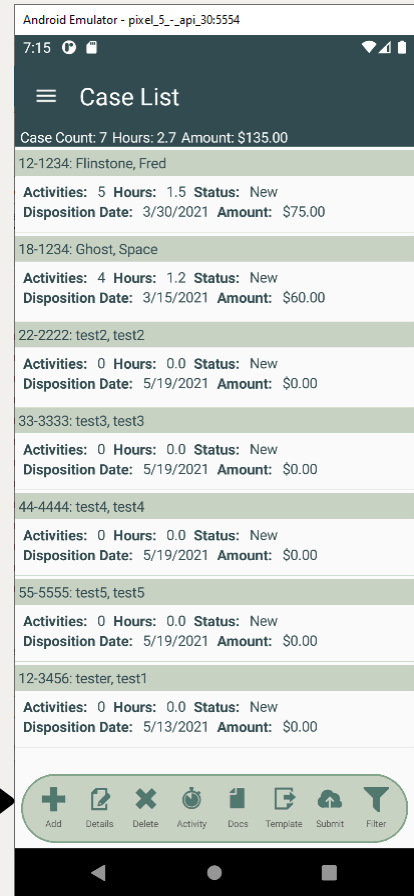

Feature Highlight: Case Entry

You're waiting in General Sessions Court for the docket call to be completed and the judge appoints a new case to you. Fortunately, you have Tabellion on your phone and you can keep track of the case easily. The first step is to click the "Add" button on the Case List page.

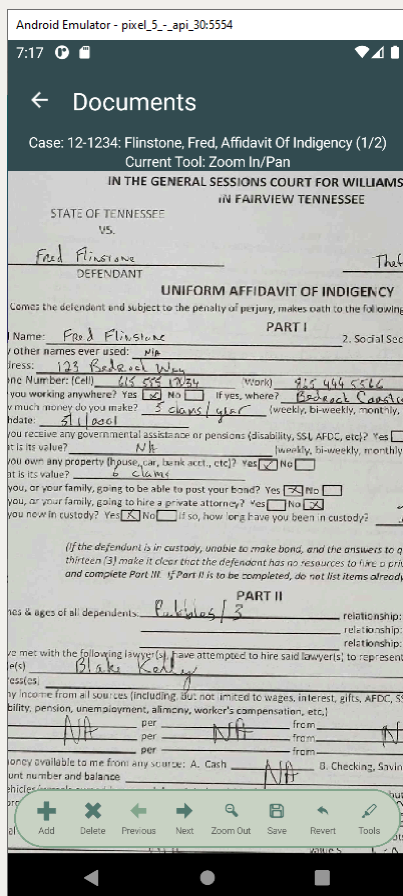
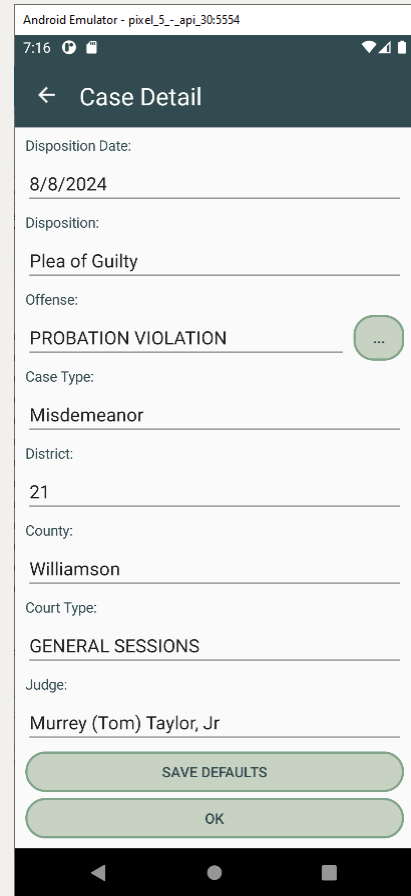


After retrieving the case file from the clerk, you have enough information to proceed. On the Case Detail page, enter the case number and your new client's name. You can quickly choose the proper offense from your most often used list or search offenses by statute number or keyword.

Feature Highlight: Case Entry

Because you have defaults setup for this court, most of the remaining information is already populated for you: case type, district, county, court type and judge.

Click Ok and you will be returned to the Case List page. Select your new case and then navigate to the Document Manager for this case by clicking the “Docs” button.




Quickly take a picture of the affidavit of indigency and it will be stored securely along with other documents that you choose to capture for the case, ready to be sent automatically when you submit the case to ACAP for billing.

In less than a minute, your new case has been entered into Tabellion and you are ready to start making time entries. If you complete this case by the end of court, you can submit it to ACAP before you leave with a click of a button!

Web App Progress

We are hard at work on the browser version of Tabellion. Here are some of the pages we have been developing: Login page, Case List page and Case Detail page. Currently, there are 28 pages in the mobile application. So far we have completed 9 of these in the web application. That's 32%!




