

Capture documents easily with your device camera and store them securely with the related case. Perform common editing functions such as cropping and redacting. Never lose an affidavit of indigence again and always have it readily available when you submit vour case to ACAP.




Case management for indigent clients






Use Doc Manager to organize all your case related documents such as affidavit of indigency, court file jackets, officer affidavits, photos, judgement sheets, hand written notes, witness statements, as well as court orders. Begin capturing documents for a case by selecting the case and clicking the Docs button.




This takes you to the Document Manager for the selected case. At the top, you will see summary of the case you are reviewing, the current document number. the total number of documents. the and currently selected tool. Click the Add button to add a new document.

Next, select the type of document you will be adding. Affidavit of Indigency is a special document type that indicates it will be uploaded to ACAP upon case submission. Capture image can be used for other documents. Click Affidavit of Indigency to continue this example.





This will display your device's camera screen. Use your device to capture an image of the document you wish to store.





After capturing an initial version of the affidavit, we need to crop it. Click the Tools button.




This displays the available editing tools. For this example, we want to click Crop to remove the unneeded border areas from the image.

From here, drag the blue crop lines to adjust the desired border for the image and click Ok.







This results in the image borders being cleaned up. Next, we want to redact undesired personal identifiers.



Zoom in on the birthdate using the standard finger pinch gesture. On the tools menu, select Redact, then drag over the area that contains the information to redact.



Continue redacting personal information such as the social security number. Click the Save button to save the redactions.



You can use the other tools to perform additional editing functions. Here, we have used the Highlighter tool to highlight the appointed counsel per AOC guidance. We have finished preparing the affidavit for submission.
